SUMMARY: This role is to perform general duties in a manufacturing environment. Duties include operating basic hand tools, assisting machine operators and welders, raw material saw operations, parts cleaning, parts deburring, parts packaging, inventory cycle counting, light assembly functions & kitting of manufacturing components. Housekeeping and material handling are also components of this position.

DUTIES AND RESPONSIBILITIES:

- Handle Materials within the shop and outdoors as required.
- Operate equipment as described in company procedures including, but not limited to metal cutting saws, drills, material handling equipment & grinders.
- Clean piece parts and finished assemblies per shop and order requirements.
- Package piece parts and finished assemblies per shop and order requirements.
- Perform work safely and follow established work procedures
- Stacks and assembles materials.
- Performs cycle counts
- Assists machine operators as needed by lifting heavy objects by hand or by use of power hoist.
- Performs other related duties as assigned by management.

QUALIFICATIONS:

- No prior experience or training.
- High school diploma or general education degree (GED), or one to three months related experience and/or training, or equivalent combination of education and experience.
- Computer skills required: Basic computer skills required for clocking into and out of work orders.
- Other skills required:
 - o Basic reading and writing skills
 - Knowledge and respect of shop safety
 - Able to perform physically demanding work
 - Ability to communicate orally
